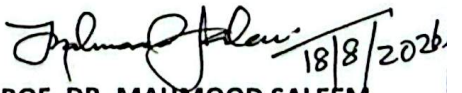

NOTICE

1. All HOD's are informed that after the completion of final merit lists of the undergraduate programs as advertised on 2nd July, 2026 for Regular programs and for Self-Supporting/Replica/Evening programs till 31-08-2026, the departments are allowed to fill the vacant seats, if any, by shifting the admission forms:
 - a) Shifting of form from Morning to Evening and vice versa.
 - b) Shifting of form from open merit to reserve quota and vice versa (reserve quota categories: PU employee's son/daughter etc., PU Teacher son/daughter etc., Special Person quota, Minority)
 - c) Shifting of form from one program to another program
 - d) Shifting of form from one campus to another

With the following conditions:

- i. The candidates must have applied for the said programs either in Morning or Evening on or before 04-08-2026 (closing date of admission form).
 - ii. They will be entertained only if they are on merit.
 - iii. The responsibility rests with the departments to inform all such applicants regarding this policy.
 - iv. The applicants seeking shifting of form from one program to another within the same department or a program in any of the department must submit applications to the concerned Head of the Department.
 - v. Those who have already submitted their admission fee of Rs. 550/- within the stipulated time will not need to pay the admission fee again.
2. Those candidates who have submitted application forms but could not submit admission Fee Rs. 550/- within the due date, are allowed to seek admission after paying Rs. 2000/- as late admission processing fee. Departments can accommodate such cases subject to the availability of vacant seats.
 3. Consider those applicants who have mistakenly admitted the form in the below mentioned category:
 - i. BS 5th Semester instead of BS 1st Semester
 - ii. BS 1st Semester instead of BS 5th Semester
 - iii. Applied on reserve seat of sports quota or co-curricular instead of open merit.
 - iv. Consider those candidates who appear in irrelevant category entry test, if otherwise eligible
 4. The facility is only available to the students who are not granted admission in any program.
 5. The priority among all categories shall be given to the applicants with higher merit.
 6. Final merit list (fifth list in case of Regular Program & 4th list in case of Self-Supporting program) shall be prepared three times of the vacant seats available from waiting list.
 7. All the departments of the University of the Punjab can add up to 10 Nos. of additional seats in each of their respective programs for admission in the current academic year 2026-27 if needed, subject to the permission of the relevant HOD's after consultation with the departmental admission committee, for both 1st & 5th Semester (morning & self-supporting). This facility is not applicable for the programs having accreditation from different councils.
 8. All applications falling under the categories mentioned at points 1, 2, and 3 above shall be forwarded to the Dean of the concerned Faculty for approval, after recommendation by the respective Head(s) of Department. In case the Dean's seat is vacant, such applications shall instead be forwarded to the Chairman, Admission Committee. These directions shall be followed in true letter and spirit.
